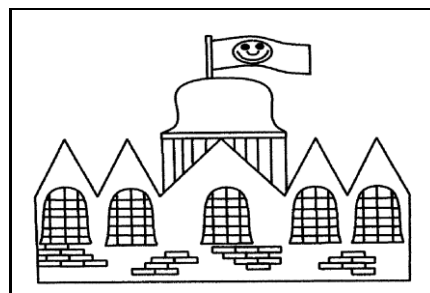

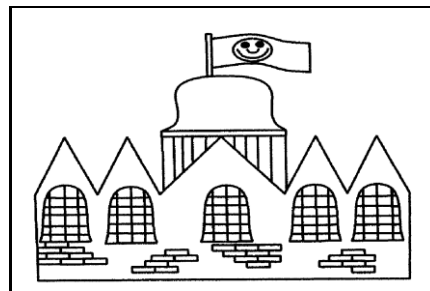

Conditions of use

1. This form is valid for the time your child attends Hillocks Primary and Nursery School. Your consent will automatically expire after this time. We will not re-use any images after this time. If you wish to remove your permission at any time please contact the school office.
2. During this period, the photos will be kept in a secure location and only authorised staff will have access to them. After this period the photographs will be privately destroyed.
3. We will only include a child's full name as photo captions for press releases if the child is not easily identifiable by a member of the public. Addresses will not be disclosed in detail. Personal e-mail or telephone numbers will not be disclosed.
4. If a pupil is named in the text of a publication, we will not use a photograph of that child to accompany the article unless we have specific consent. For example, we might want to include a picture and a full name of a competition winner. However, we will not include a picture and full name of a child in promotional literature.
5. We may use group or class images with very general labels, such as a 'literacy hour' or children exploring the environment.
6. We will only use images of pupils who are suitably dressed, to reduce the risk of such images being used inappropriately.
